ANNOUNCEMENT OF PRE-REGISTRATION PERIOD

1. National Delivery Champions Association intends to hold its inaugural branch general meeting for all its recognised branches during the period of 30 March 2026 to 10 April 2026.
2. NOTICE IS HEREBY GIVEN that, in accordance with Clause 22(e) of the Constitution of National Delivery Champions Association (hereinafter known as "NDCA"), a Pre-Registration Period shall be applicable as follows:

Date: Tuesday, 30 December 2025 to Monday, 16 March 2026

3. Ordinary Members who wish to attend, speak, vote or stand for election at the branch general meetings must fulfil the following eligibility criteria:
 - a. Continuous membership under NDCA of at least 12 months without any outstanding membership fees.
 - b. in any continuous period of 30 days during the Pre-Registration Period, have performed 100 or more tasks in the provision of any delivery platform service, out of which:
 - (1) 50 or more tasks must be in the provision of delivery platform services with the platform operator which has accorded recognition to this Association under the Industrial Relations Act 1960*, and is associated with the Branch to which the Ordinary Member belongs to; and
 - (2) at least 1 task must have been performed within the last 2 months and 2 weeks of the Pre-Registration Period.
 - c. furnish during the Pre-Registration Period, **on or before 16 March 2026**, documentary proof of their fulfilment of the sub-rule above as the Executive

Committee may require in its absolute discretion. Documentary proof will include, but is not limited to:


